IMPORTANT – READ BEFORE SIGNING – THIS IS A LEGAL PROMISSORY CONTRACT!

I hereby promise that I am at least 18 years of age and am able to enter into the terms of this contract.

I hereby acknowledge receiving the above described animal.

I agree to provide proper food, water, adequate shelter, and kind treatment at all times.

I agree to take described animal to a veterinarian for examinations/immunizations as needed; and to procure immediate veterinary care, at my own expense, should the animal become ill or injured.

I agree to have the above described animal sterilized by a licensed veterinarian no later than _____, unless said animal has been sterilized prior to this contract. If the surgery is performed at a location other than designated clinics, I agree to provide written confirmation of the surgery by the performing facility to Diane Buterin, DB's Dogs.

I agree to license the animal in compliance with the laws and ordinances in force in the municipality in which I reside.

I agree to notify Diane Buterin, DB's Dogs, if I decide at any time that I can no longer keep the animal.

I agree not to allow the animal to be used for any medical or experimental purposes.

I agree that if I do not have a heartworm test performed on this animal within 72 hours of signing this agreement, Diane Buterin, DB's Dogs will not be liable if animal develops heartworms at a later date.

I have read or have had the above rights and obligations explained to me.

I understand that Diane Buterin, DB's Dogs cannot guarantee the health, temperament, or training of the above described animal and hereby agree to release Diane Buterin, DB's Dogs from all liability once the animal is in my possession. It is also understood that Diane Buterin, DB's Dogs strongly suggests that the adopted animal should be kept in quarantine from other animals until a veterinarian can perform a thorough examination of said animal.

I agree that this document be interpreted and construed according to the laws of the State of Missouri to the exclusion of any other State and that any action on it will be brought in the courts of the State of Missouri only.

I agree that if Diane Buterin, DB's Dogs should take any legal action to enforce this agreement whatsoever, the adopter will be responsible for payment of any costs and/or attorney's fees incurred by Diane Buterin, DB's Dogs in enforcing this agreement.

EXCLUSIVE REMEDY FOR NON-COMPLIANCE: It is agreed that Diane Buterin, DB's Dogs retains superior title in said animal limited to and for the express purpose of assuring the animal's well being and only exercise its superior claim in the event it appears to Diane Buterin, DB's Dogs that the proper and humane care as specified in the above adoption provisions is not being afforded to said animal. In this event, the animal may be taken through a Claim & Delivery proceeding. The adopter hereby agrees that remedies at law may not be adequate, and therefore, Diane Buterin, DB's Dogs will have available to it all remedies available in equity.
